A campus has been developed with lush-green resort-like infrastructure. To sustain for the long term, we have already developed a professional organizational structure driven by recruiting qualified and experienced staff, guided by one of the trustees Paragbhai Shah.

We are thankful to all the members of the trust, members of advisory committee and members of the medical board for their support and motivation. We are also thankful to our staff members for their involvement, love & care for our beloved intellectually challenged individuals. Come forward, together let us complete this spiritual journey...

HISTORY AND CONCEPT

Historical Perspective

SOCIETY FOR THE WELFARE OF THE MENTALLY RETARDED was established in 1968 and it was the first group of parents that enrolled their children with us.

The aim of the association was to comfort the parents and answer their question 'Who will take care of our children after us?'.

To fulfil parents' concerns AASTHA CHARITABLE TRUST FOR THE MENTALLY CHALLENGED was formed with the mission to provide a dignified life and qualitative care through a residential 'HOME' for the persons with intellectual and developmental disabilities through community mobilisation and parents' partnership. The assisted living facility was inaugurated on 21st February 2016 by the then Chief Minister of Gujarat, Anandiben Patel. This place has become famous as 'Anand Dham'- an Abode for Persons with Intellectual Disabilities. It is a green belt of eight acres in Aadroda village, Ta.: Bavla, Dist.: Ahmedabad.

ABOUT ANAND DHAM

Anand Dham is a residential resort for God's chosen ones. The home is built for intellectually challenged individuals who need special care, at an age when they need to be looked after for a longer duration by being under someone's constant supervision. It has abundance of nature around for the individuals to get acquainted with, while we provide them with adequate physical and stimulating activities, and engage them in a safe, secure premise. Anand Dham's endeavour is to offer the challenged individuals a quality of life that their aging parents want them to enjoy after they are gone. We offer group accommodation or cubical units and several other residential options that include supervised and independent living. Along with our residential program, we also offer basic training in life skills. Our goal is to provide quality services by offering and training individuals on a one-to-one basis for meaningful, skilful, and competitively paid jobs in the organization. We provide various vocational opportunities so that everyone can be trained according to their needs and can be given the opportunity to choose the type of job they are interested in.

ACTIVITIES

At the end of the FY 2021-22 total 69 residents (53 boys and 16 girls) started living in the facilities available at Anand Dham. To provide them with the best of services on campus, Anand Dham organises various activities so that they can feel at home and enjoy each day of their lives.

- 1. Opportunity for sustainability through campus placement as part of Vocational Training.
- 2. Training in Domestic Skills and Soft Skills.
- 3. Exercises, Yoga and Walking.
- 4. In-Door and Out-Door games.
- 5. Leisure time activity including watching TV, Watching Movie, Celebration of various festivals, Dancing, Music, painting, playing Games.
- 6. Recreational Activities like celebration of Birthdays, Gardening and Plantation.

The residents of Anand Dham follow daily schedules of ON-THE-JOB TRAINING PLACEMENT at various departments on campus. In addition to ADL and vocational training, they also perform housekeeping activities as a part of independent living. Our services are designed to support everyone to live a sustainable independent life and actively engage in their areas of interest. All the festivals are celebrated at Anand Dham including birthday celebrations of all the residents.

Activities of Daily Living (Toileting, Brushing, Bathing), Morning Walk, Yoga, Physical Exercises and Laughing Exercises, Tea – Breakfast, Medicine Time, Bathing , Juice time, Workshop Activity / Campus Placement / Prevocational, Lunch, TV Time, Rest time, Washroom Time, Own Clothes and Cupboard Arrangement, Outdoor Game / Gym Exercises, Evening Walk, Dinner, TV Time, Milk Time - Bed Time. The Intermediate Care Facilities are age and health specialized services, personal care, housekeeping, medication administration, therapeutic, social and recreation programming, fitness, and on-site nursing services. Meaningful vocational employment opportunities such as Gardening, Laundry work, cutting & cleaning vegetables, refrigerator cleaning etc.





BIRTHDAY CELEBRATION

We celebrate group birthdays on the third Saturday of every month... Last year, due to the pandemic, it was difficult for us to celebrate birthdays. But this year we were able to celebrate everyone's birthday with individual cakes. We have also started inviting guests to celebrate birthdays on campus and share their happiness with our "children". This has created a huge success in changing the mentality of the society that these angels are also a part of our society. On the other hand, our "children" are also happy to meet new people on the campus. It gives them a feeling of inclusivity by the society.



VACCINATION DRIVE

COVID-19 had affected the whole country and we were not spared either. We faced a tough time during the first and second waves of COVID-19 and since then we have started taking preventive measures to save everyone from this pandemic. With the support of a nearby primary health centre, all our residents and staff members completed the first and second doses of the COVID-19 vaccine. We are now discussing with the primary health centre to give booster dose to our residents above age 60.



INCOME GENERATING ACTIVITIES

Although our residents are intellectually disabled, many of them are productive and have got prevocational training during their childhood. We do not want them to be idle and become lazy. We try our best to give them activities according to their abilities. And therefore, many of them are engaged in Diya making, Thermocol and paper cutting and paper bowl and dish making activities. We make sure that they work under supervision to protect themselves from any hazards. Income raised from the products are shared equally between our residents.

CLEANLINESS DRIVE

Cleanliness is one of the most important parts of the Anand Dham campus. We always keep our campus clean and green. Although we have enough staff for this, we always involve our residents in cleanliness activities to teach them the importance of cleanliness in our life. Periodically we also organise cleanliness drives on campus and encourage our residents to take part in this activity. The main area of this activity is their rooms and garden. We teach them how to keep their rooms clean so that they can live in a healthy environment.



INTERNATIONAL DAY FOR PERSONS WITH DISABILITIES

December 3 is observed as the International Day for People with Disabilities. We organised sports day for our residents and encouraged them to participate in each game. Simple games like lemon-spoon and soft ball throw was organised for our residents. Everyone was given a prize

at the end of the event.

TREE **PLANTATION**

We teach our residents to take care of our mother nature. And therefore, we regularly organise tree plantation activities during their birthdays. Residents take responsibility to look after the plants and water them every day. We have also put bowls in our campus for water and food for birds. This year, Voluntary Nature Conservancy donated us nests and earthen bowls for sparrows.

NATIONAL FESTIVALS CELEBRATION

Anand Dham celebrated Republic Day and Independence Day on campus. We invited the Sarpanch of Aadroda village as our guest for the flag hoisting ceremony. We remembered our rights and responsibilities as Indian citizens and pledged to sacrifice our life for India.

INAUGURATION OF COMPUTER CENTRE

On December 3, 2021, a computer centre was inaugurated on campus. There are some residents who can operate the computer and learn basic skills. This centre has become very useful to them as they can play games, watch videos, and draw pictures.







INTERNATIONAL KITE FESTIVAL

On January 16, 2022, Anand Dham organised International Kite Festival on campus to entertain the residents. A team of international kite flyers agreed to organise the kite festival with our residents to make them happy. They brought different types of kites and flew in the sky. Many of our residents saw these kites for the first time in their life.

CAREGIVERS TRAINING FOR STAFF MEMBERS

To update the knowledge of our caregivers of Anand Dham, we organized a training session for two days for the Caregivers December 29-30, 2021 with the support of the Blind People's Association. Nandini Raval and Vimal Thavani shared their knowledge with our caregivers. The sessions designed for the training program were quite related to the level of our caregivers and they enjoyed the training program.



VISITORS

On January 19, Anand Dham campus witnessed Acharya Harshshil Suriji's presence on campus. He visited Anand Dham and blessed the staff members and children.

On August 30, Education Minister of Gujarat Bhupendrasinh Chudasama visited Anand Dham during the foundation stone ceremony of our second phase of construction.

On July 19, 2021, Dr. R. N. Prasad, Director of Center for Entrepreneurship Development, Gandhinagar visited the campus and met our residents and staff.

Since the beginning of Anand Dham, it was our plan to create infrastructure to accommodate 200+ inmates in our campus.

At present 70 inmates are happily living in Anand Dham and enjoying rest of their life. After the acquisition of new land, we organised Bhumi Pujan ceremony for the second phase of construction on the 30th of August 2021, Monday.

The Chief Guest of the ceremony was Shri Bhupendrasinh Chudasama, Minister of Education and Law, Government of Gujarat.

Guest of Honour of the ceremony was Padma Shree Dr. Sudhir Shah, reputed Neurologist of India, Shri Mihir J. Thakor a reputed senior advocate, Shri Pravinbhai A. Shah, President of Ambawadi Jain Sangh and Shree Naren Mehta were also graced the ceremony being guest of honours.

The ceremony started with the prayer by divyang girls of Anand Dham. In the welcoming speech, Shri Rajubhai Shah, Managing Trustee welcomed all the dignitaries and said that Anand Dham is not just a residential set up, but it is a new concept of living and making them busy. He said that Anand Dham is trying its best to keep inmates busy and therefore a huge workshop is taking place in Anand Dham campus to give enough work to them. He said the Anand Dham needs support from nearby industries to get job work which is suitable to our inmates. Ushaben Thakur, Mother of Samir Thakur shared her experience of Anand Dham. She said that due to her age, she is not able to look after Samir but now she is the happiest mother and very satisfied to put her son in Anand Dham. She appreciated priceless efforts of Anand Dham to keep Samir active through different activities.

Dr. Sudhir Shah appreciated dedication of trustees and thanked them to start this organisation. He appealed everyone to come forward and support this organisation. He explained the word Divyang and said that these people are not retarded but have special skills which we need to identify and work on it. They can be useful members of the society if given opportunity.

Mr. Mihir Thakor shared an experience of his visit to Anand Dham. He said that he visited Anand Dham hiding his identity and verified about this organisation. He said that he found Anand Dham is very well managed organisation and for that he complimented all the trustees. After the verification, he donated Rs. 1 crore to Anand Dham.

Shri Bhupendrasinh Chudasama was very much impressed with the facilities of Anand Dham and thanked all the trustees for taking care of smallest needs. He called divyang people as God and said that taking care of divyang is as equal as taking care of God. He said that all the staff members of Anand Dham are taking care of God and it is a holy work. He said that sometimes God is not able to come and help the people but send someone. He said that God sent Rajubhai to help all divyang people in Anand Dham.

The bhumi pujan was very successful and everyone worked hard for it.


